This product has been designed and manufactured by Something Different Wholesale LTD. Our Crystal products have not been designed for the use of children, as some may contain small parts. Each product is clearly labelled to keep out of the reach of children, and 'this is not a toy' is stated on the packaging. All crystal products are tested under Registration, Evaluation, Authorisation and Restriction of Chemicals, and is the EU Regulation (EC) No 1907/2006 to ensure, Lead content must not exceed 0.05% by weight, and cadmium must not exceed 0.01%. We require products to pass Testing Standard: EN 1811:2011 for nickel, lead, and cadmium release. Nickel must not exceed 0.5  $\mu\text{g}/\text{cm}^2/\text{week}$ . Our Crystal and Jewellery is tested according to testing standard is EN 12472 (simulation of wear and corrosion) followed by EN 1811.
