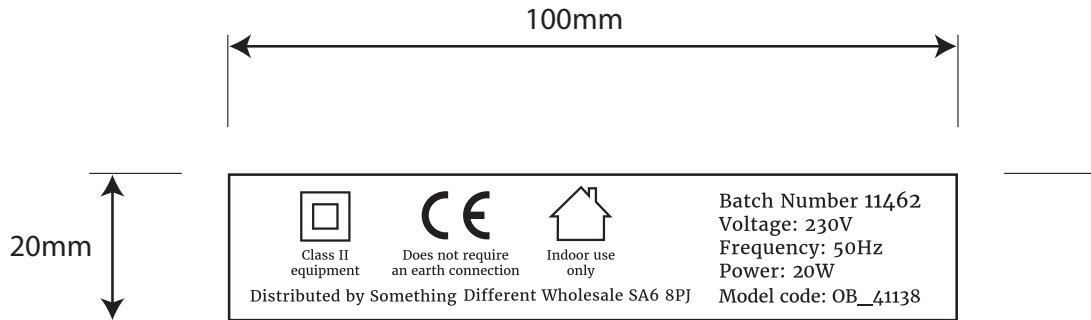

### Warning:

2. Do not place the burner in a location where it will be easily knocked over.

7. Do not touch or move burner while it's in use.

If the external flexible cable of this wax melt burner is damaged, it should only be replaced by a qualified person to avoid hazard.

### How to use:

- Remove all packaging before use.
- Ensure the burner is placed on a flat, clutter free, and heat-resistant surface.
- Fill the dish with an appropriate amount of wax, do not overfill the dish. If using a fragrance oil, use 2 to 3 drops of oil diluted with water.
- Plug in the electric wax melt burner and switch on.
- Check your electric burner periodically. Maintain an appropriate level of oil or wax in the dish.
- Switch off the electric wax melt burner and unplug from the mains when not in use. Allow the burner to cool completely before moving.

### How to clean:

- Allow burner to completely cool before cleaning.
- To remove wax, wait for wax to harden then carefully scoop out.
- Clean residue in dish with warm soapy water and dry.
